ARRI Rental COVID-19 GOLDEN RULES

- 1. All checkouts and visits **are by appointment only.** Checkout times must be strictly adhered to, this will allow proper social distancing between crews.
- A "Health Declaration" form must be completed and signed by all crew and visitors prior to
 entering the facility. Entry to the facility is dependent on approval of your health declaration
 by the facility manager.
- 3. If your production company has required you to take a COVID-19 test prior to your job you **must** wait for the results before entering the building.
- 4. On arrival, we will take your temperature. If your temperature is over 100.4 F you will not be allowed access to our buildings.
- 5. Masks are required to enter the facility and must be worn at all times.
- 6. We have implemented a very strict and comprehensive disinfection process. Once cleaned and disinfected, all equipment will be sealed. While the equipment is in your care, if additional cleaning is required, any substance used must be approved by ARRI Rental in advance. If not, there is a risk of permanent and costly damage to the equipment.
- 7. A reasonable cleaning charge will be added to your final invoice.
- 8. All personal crew gear and equipment must be taken directly into your designated prep area and remain there, not leaving the area, until the end of your prep period.
- 9. There will be **NO** storage of personal crew gear, equipment, and carts at any time in ARRI Rental facilities outside of your scheduled prep.
- 10. Movement between departments will be restricted. Staff will be in place to support you during your prep.
- 11. Dedicated "red zones" are located throughout facilities and are clearly marked by red tape. These zones are to be entered by ARRI Rental Employees **ONLY**. These are designated areas for the decontamination of equipment. Do **NOT** enter these areas.
- 12. Please always observe social distancing guidelines of 6 feet. Floor markings will be in place. Be alert, keep your head up, and please pay attention.
- 13. Inevitably, there will be some areas where social distancing cannot be maintained, for example, the toilet facilities. These should be used by one person at a time. We ask that the utmost care is taken when approaching these areas, knocking before entering and using common sense to navigate around people. All hand dryers have been disabled to reduce any airborne spread of germs.
- 14. Due to the risks of fluid spread when using an aerosol, any use of compressed air cans within the building is restricted to your designated prep area and used with great caution and at your own risk.
- 15. To limit the potential spread of the virus, no food or beverage will be provided to crews during prep. Crews are permitted to bring in their own personal food and beverage.
- 16. Please use the handwashing facilities and sanitizing gel dispensers available throughout the building.
- 17. Please be aware additional time will be needed to finalize all returns to due equipment quarantine procedures and additional cleaning.
